Our Counselor-in-Training camp is designed for mature and enthusiastic campers who are interested in developing leadership skills and working with children. The expectations of CITs are high as the younger campers look to them as role models. CITs are expected to willingly and fully participate in camp programs and to cooperatively work with other CITs and Camp Staff as a positive influence on the camp community. Throughout the summer, CITs make lasting friends and experience camp from a new perspective. Many of our CITs often become camp counselors.

The CIT camp is open to rising 8th – 10th graders (8th – 9th grades at Somerset Hills YMCA). Completed applications must be submitted for consideration and acceptance into the CIT program. Applicants who are accepted into the program will be notified within one week of the date the application is received. Once accepted, candidates can register for one of the CIT sessions. We encourage applicants to submit the applications early, as limited space is available. Also, please note that participating in the CIT program does not guarantee a staff position. CITs are evaluated on their performance and will be entitled to a "priority" interview for a Junior Counselor position when they become age eliqible.
